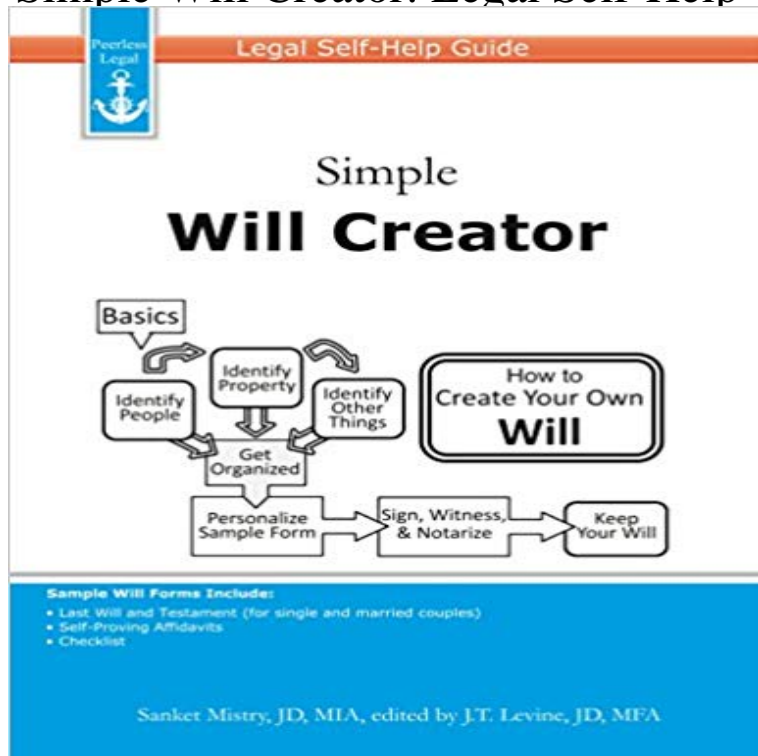


# Simple Will Creator: Legal Self-Help Guide
