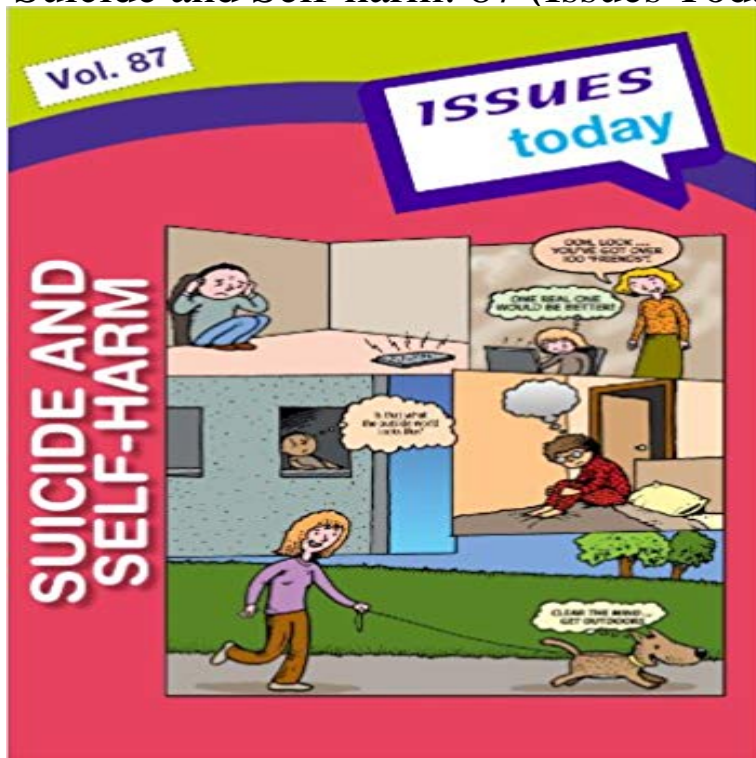


# Suicide and Self-harm: 87 (Issues Today)
