

President Obama has declared that the standard by which all policies and policy outcomes are judged is fairness. And that, he says, is why we have a social safety net. He says that returning to a standard of fairness where anyone can get ahead through hard work is the issue of our time. And perhaps it is. Does it mean the government can assert the authority to forcibly take from the successful and give to the poor? Is government supposed to be Robin Hood determining who gets what? Or should the market decide that? The surprising answer: nations with free market systems that allow people to get ahead based on their own merit and achievement are the fairest of them all.
